Each share of Class B common stock is convertible at any time at the option of the Reporting Person into one share of Class A common stock. In addition, each share of Class B common stock will automatically convert into one share of Class A common stock (a) upon transfer thereof, subject to certain exceptions, (b) upon the date on which the outstanding shares of Class B common stock represent less than 10% of the aggregate number of shares of the then

outstanding Class A common stock and Class B common stock, or (c) in the event that holders of at least 66^{2/3}% of the then outstanding shares of Class B common stock elect to convert all shares of Class B common stock into shares of Class A common stock.
