The reporting person earned a total of 42,380 shares in respect of performance-based restricted stock units (PBRUs) for the 2015-2016 performance period, which were granted to the reporting person as restricted stock units on 3/1/17. Amount represents 50% of the shares subject to such restricted stock units which vested on 3/1/17 (date of grant).

- (2) Represents shares reacquired to satisfy tax withholding obligations in connection with the vesting of 21,190 shares subject to restricted stock units granted to the Reporting Person in respect of PBRUs for the 2015-2016 performance period (see footnote 1).
- (3) Each restricted stock unit represents a contingent right to receive one share of PayPal's common stock.

- (4) The reporting person received a restricted stock unit grant subject to a three-year vesting schedule, vesting 33.34% on the one year anniversary date of the restricted stock unit, 33.33% on the second year anniversary, and 33.33% on the third year anniversary. Upon vesting, the reporting person will receive a number of shares of common stock equal to the number of restricted stock units that have vested.

- (6) The reporting person earned a total of 42,380 shares in respect of performance-based restricted stock units (PBRUs) for the 2015-2016 performance period, which were granted to the reporting person as restricted stock units on 3/1/17. Amount represents 50% of the shares subject to such restricted stock units vesting on the first anniversary of the date of grant.

- (7) The option grant is subject to a four-year vesting schedule, vesting 12.5% on the 6 month anniversary of the grant and 1/48th per month thereafter.

- (8) The reporting person received restricted stock units subject to a four-year vesting schedule, vesting 25% on the one year anniversary date of the restricted stock unit and 25% each year thereafter. Upon vesting, the reporting person will receive a number of shares of common stock equal to the number of restricted stock units that have vested.
