On April 26, 2007, Mr. Wathen was credited with 798.54 Stock Units for payment of his annual retainer and 68.45 Stock Units for payment of board meeting fees. At distribution, Mr. Wathen may elect pursuant to the terms of the Plan to receive his deferred compensation either in shares of Franklin common stock or in cash.
