Item 2.02 Results of Operations and Financial Condition.

On March 3, 2016, Stage Stores, Inc. (“we,” “us,” “our” or “registrant”) issued a news release reporting our unaudited financial results for the fourth quarter and fiscal year ended January 30, 2016. Additionally, we provided full year 2016 guidance.

The news release included “non-GAAP financial measures,” as that term is defined by Rule 101 of Regulation G (17 CFR Part 244) and Item 10 of Regulation S-K (17 CFR Part 229). Specifically, the following non-GAAP financial measures were included: (i) adjusted net income; (ii) adjusted diluted earnings per share; (iii) adjusted gross profit; and (iv) adjusted expenses. The non-GAAP financial measures exclude from the most directly comparable financial measure calculated and presented in accordance with accounting principles generally accepted in the United States of America (“GAAP”), the following items: (a) in connection with the consolidation our corporate headquarters, an after-tax charge of approximately \$1.2 million, or \$0.04 per diluted share for the fourth quarter of fiscal 2015, and \$2.4 million, or \$0.07 per diluted share for the year; (b) in connection with our store closures and other strategic initiatives, an after-tax charge of approximately \$2.9 million, or \$0.10 per diluted share for the fourth quarter of fiscal 2015, and \$8.2 million, or \$0.26 per diluted share, for the year; and (c) in connection with our workforce reduction initiative and pension settlement, an after-tax charge of approximately \$1.8 million, or \$0.06 per diluted share for the fourth quarter of fiscal 2015 and for the year. The news release posted in the Investor Relations section of our website contains a presentation of the most directly comparable financial measure calculated and presented in accordance with GAAP and a reconciliation of the difference between the non-GAAP financial measures and the most directly comparable financial measures calculated and presented in accordance with GAAP.

We believe this supplemental financial information enhances an investor’s understanding of our financial performance as it excludes those items which impact comparability of operating trends. The non-GAAP financial information should not be considered in isolation or viewed as a substitute for net income, cash flow from operations or other measures of performance as defined by GAAP. Moreover, non-GAAP financial information as reported by us is not necessarily comparable to other similarly titled measures of other companies due to the potential inconsistencies in the method of presentation and items considered.
