Time-based restricted stock units granted under the terms and provisions of the Unisys Corporation 2003 Long-Term Incentive and Equity Compensation Plan. All or a portion of the award has been deferred under the terms and provisions of the 2005 Deferred

(1) Compensation Plan for Directors of Unisys Corporation. Deferred units will be distributed in shares of Unisys common stock either upon the earlier of termination of service or on any date at least two years after the stock units are awarded, as previously elected by the director.
