Magnetek, Inc. (the "Company") announced that its chief executive officer, Peter McCormick, and its chief financial officer, Marty Schwenner, will present to institutional investors and analysts at the Lambert, Edwards & Associates SMID-West Stock Conference to be held on December 8, 2010. The presentation will be accompanied by a slide presentation in both hard copy and electronic format. Certain of these slides contain financial information relative to the Company's past performance and estimated performance for the remainder of the fiscal year ending July 3, 2011. The Company may, in the course of its financial presentations, earnings releases, earnings conference calls, and otherwise, publicly disclose certain numerical measures which are or may be considered "non-GAAP financial measures" under SEC Regulation G. "GAAP" refers to generally accepted accounting principles in the United States. Non-GAAP financial measures disclosed by management are provided as additional information to investors in order to provide them with an alternative method for assessing the Company's financial condition and operating results. These measures are not in accordance with, or a substitute for, GAAP, and may be different from or inconsistent with non-GAAP financial measures used by other companies. The Company's presentation includes non-GAAP measures such as EBITDA and adjusted EBITDA. EBITDA represents its GAAP results adjusted to exclude interest, taxes, depreciation and amortization. Adjusted EBITDA represents EBITDA adjusted to exclude non-cash pension and stock compensation expenses.
