- (1) This Amendment corrects the "execution date" in the original filing. The purchase occurred on October 10, 2008 and settled on October 14, 2008.
  - (2) Overseas Shipholding Group, Inc. ("OSG") indirectly owns 100% of OSG America LLC ("OSG GP"), the sole general partner of the Issuer. OSG GP owns a 2% general partner interest in the Issuer.  
  
Subsidiaries of OSG own an aggregate of 8,000,434 common units and 14,999,999 subordinated units of the Issuer. OSG GP owns 612,245 general partner units and also owns incentive distribution rights ("IDRs"), which represent the right to receive an increasing percentage of quarterly distributions in excess of specified amounts. OSG is the indirect beneficial owner of the general partner interest in the Issuer and the IDRs owned by OSG GP.
