- (1) During the fiscal year under the Cedar Fair, L.P. Distribution Reinvestment and Employee Unit Purchase Plan, 388 units were acquired at prices ranging from \$21.55 to \$29.06. These transactions are exempt under rule 16a-11.
- (2) During the fiscal year under a broker administered distribution reinvestment plan, 47 units were acquired at prices ranging from \$23.90 to \$28.90. These transactions are exempt under rule 16a-11.
