Item 1.01 Entry into a Material Definitive Agreement.

On May 18, 2007, EOG Resources, Inc. (EOG) amended its 5-year \$600 million unsecured Revolving Credit Agreement (Agreement) with domestic and foreign lenders and JPMorgan Chase Bank, N.A., as Administrative Agent, to increase the facility from \$600 million to \$1 billion and to provide EOG the option to request letters of credit to be issued in an aggregate amount of up to \$1 billion, replacing the previous limitation of up to \$200 million. Concurrent with the effectiveness of the amendment, the maturity date of the Agreement was extended from June 28, 2011 to June 28, 2012. There are no borrowings or letters of credit currently outstanding under the Agreement.

Item 7.01 Regulation FD Disclosure.

I. Price Risk Management

With the objective of enhancing the certainty of future revenues, from time to time EOG Resources, Inc. (EOG) enters into New York Mercantile Exchange related financial commodity collar and price swap contracts. EOG accounts for these financial commodity derivative contracts using the mark-to-market accounting method. In addition to financial transactions, EOG is a party to various physical commodity contracts for the sale of hydrocarbons that cover varying periods of time and have varying pricing provisions. The financial impact of physical commodity contracts is included in revenues at the time of settlement, which in turn affects average realized hydrocarbon prices.

II. Natural Gas Financial Price Swap Contracts

Since EOG filed its Quarterly Report on Form 10-Q on April 30, 2007, EOG has entered into additional natural gas financial price swap contracts covering notional volumes of 40,000 million British thermal units per day (MMBtud) for the period January 2008 through December 2008 at an average price of \$9.05 per million British thermal units (MMBtu). Presented below is a comprehensive summary of EOG's natural gas financial price swap contracts as of May 23, 2007.
