SMALLCAP World Fund, Inc., an investment company registered under the Investment Company Act of 1940, which is advised by Capital Research and Management Company ("CRMC"), is the beneficial owner of 9,921,646 shares or 8.6% of the 109,979,652 shares of Common Stock believed to be outstanding. CRMC manages equity assets for various investment companies through two divisions, Capital Research Global Investors and Capital World Investors. These divisions generally function separately from each other with respect to investment research activities and they make investment decisions and proxy voting decisions for the investment companies on a separate basis.

Shares reported by SMALLCAP World Fund, Inc., include 5,341,368 shares resulting from the assumed conversion of 48,286 shares of the 13.0% Convertible Preferred Series C.
