Shares of Company common stock will be issued in substantially equal increments on the first, second and third anniversaries of the date of grant, in each case subject to tax withholding requirements.
- (2) These options were granted on January 3, 2017 pursuant to the Chart Industries, Inc. Amended and Restated 2009 Omnibus Equity Plan in an exempt transaction under Rule 16b-3. The options vest with respect to one-fourth (1/4) of the total number of shares of common stock underlying the stock options on each of the first four anniversaries of the date of grant.
