Glenview Capital Management serves as investment manager to each of Glenview Capital Partners, Glenview Capital Master Fund, Glenview Institutional Partners, Glenview Offshore Opportunity Master Fund, Glenview Capital Opportunity Fund, GCM Master Fund and the Managed Account. Mr. Robbins is the Chief Executive Officer of Glenview Capital Management.

This amount consists of: (A) 771,040 Shares held for the account of Glenview Capital Partners (B) 8,039,961 Shares held for the account of Glenview Capital Master Fund (C) 2,661,638 Shares held for the account of Glenview Institutional Partners (D) 5,969,271 Shares held for the account of Glenview Offshore Opportunity Master Fund (E) 6,194,814 Shares held for the account of Glenview Capital Opportunity Fund (F) 952,700 Shares held for the account of GCM Master Fund and (G) 1,187,769 Shares held for the Managed Account.

As of December 31, 2018, Mr. Robbins may be deemed the beneficial owner of 25,781,193 Shares. This amount consists of the 25,777,193 Shares beneficially owned by Glenview Capital Management plus 4,000 Shares held in certain custodial accounts controlled by Mr. Robbins.
