Thank you for contacting us with regard to the proposed merger of the businesses of HUGHES and EchoStar Communications Corporation.

Although we are unable to provide specific answers to some questions due to the nature of the regulatory review process, highlights of the merger include;

- Local Channels For All Americans

Consumers across the contiguous United States, Alaska and Hawaii will have access to local broadcast channels with digital-quality television picture and CD-quality sound in every one of the 210 television markets across the country. Not every customer will require new equipment. New set-top boxes and satellite dishes will be deployed that will be capable of receiving satellite signals from multiple orbital positions. EchoStar has agreed that the new receiving equipment will be made available free of charge to all existing DIRECTV and DISH Network customers who may need it in order to receive their local channels.

-- One Nation, One Rate Card

Consumers across the country will pay the same price for services delivered by the merged DBS service, regardless of a subscriber's location. This means that a resident in a community of five will pay the same rate as a resident in a city of five million.

--Broadband For All Americans

The merged company also will potentially establish itself as a source of meaningful satellite-based broadband competition, fulfilling the mission to provide affordable high-speed Internet access to all of America, including the most rural areas of the country. Some 40 million households in the United States do not have access to high-speed Internet and data services, in large part due to the high cost of wiring homes for these services in less densely populated areas.

We continue to seek the required regulatory clearances and approvals with a goal toward completing the merger in the second half of 2002.
