YAHUD, Israel, January 10 /PRNewswire-FirstCall/ -- Magal Security Systems, Ltd. (NASDAQ: MAGS; GM: MAGS; TASE: MAGS), today announced its wholly owned UK subsidiary, Senstar-Stellar Limited, has received an order of approximately US\$ 1.3 million. The order is to replace a personnel-attack alarm system at the State Hospital Facility in Scotland with Senstar-Stellar's FLARE(R) Emergency Locating System. The work will be completed during 2007.

The FLARE Emergency Locating System uses a patented RF technology that can accurately locate both indoor and outdoor events. By utilizing bi-directional audio, the system also enables the control room to communicate with personnel located in the area of the alarm allowing the exchange of real-time information.

Izhar Dekel, CEO of Magal, said: "This order is from a client with a long working history with our UK-based Senstar-Stellar subsidiary. We are proud that we are able to provide this client with a state-of-the-art safety system, having previously supplied perimeter security sensors for this facility. This is another demonstration of our continuing commitment to provide a broad spectrum of security solutions to our customers."
