VANCOUVER, BC VANCOUVER, BC Peace Arch Entertainment Group Inc. (AMEX: "PAE"; TSE: "PAE.A", "PAE.B"), a leading independent television production company in Canada, today announced that it has terminated the previously announced Letter of Intent to acquire the business of a private U.S. company which owns a library of television programming. The Letter of Intent was subject to certain conditions, which were not fulfilled by the recent expiration date of July 31, 2002.

In connection with the proposed acquisition, Peace Arch had engaged a New York investment banking firm to provide financial advisory services and assist with a financing. Peace Arch is continuing discussions with both parties, on a non-exclusive basis, with respect to a new
