How the Redemption Amount at Maturity is Calculated

The Redemption Amount at Maturity will be determined as follows:

- ·If the Ending Level is greater than the Starting Level, then the Redemption Amount at Maturity will equal: Principal Amount + (Principal Amount x Participation Rate × Percentage Change)
- If the Ending Level is less than or equal to the Starting Level, but greater than or equal to the Threshold Level, the Redemption Amount at Maturity will be equal to \$1,000
- ·If the Ending Level is less than the Threshold Level, the Redemption Amount at Maturity will be equal to: Principal Amount + (Principal Amount × Percentage Change)
