The additional shares of restricted stock will vest as follows: 173 shares in even increments over 2 years beginning January 2, 2017, 76 shares in even increments over 3 years beginning January 2, 2017, 99 shares in even increments over 3 years beginning August 25, 2017, 255 shares in even increments over 4 years beginning January 2, 2017 and 315 shares in even increments over 5 years beginning January 4, 2017.
