The Registrant is unable to file its Quarterly Report on Form 10-Q for the quarter ended December 31, 2010 within the prescribed time period due to the additional time and effort needed to integrate the financial statements of Central Jersey Bancorp which was acquired on November 30, 2010 with those of the Registrant. The Company intends to file the Form 10-Q with the SEC as soon as practicable, and will make every effort to file the Form 10-Q within the five-day extension period afforded by SEC Rule 12b-25 under the Securities Exchange Act of 1934, as amended.

Attachment B

For the quarter ended December 31, 2010, the Registrant reported a net loss of \$5,000, a \$0.00 per diluted share, compared to net income of \$1,841,000 or \$0.03 per diluted share for the quarter ended December 31, 2009. The decrease in net income was primarily attributable to merger-related expenses attributable to the Registrant's acquisition of Central Jersey Bancorp and its wholly owned subsidiary, Central Jersey Bank, National Association which was completed on November 30, 2010.
