The Bank of New York Mellon Corporation, One Wall Street, New York, NY 10286, U.S.A., disclosed on January 30, 2015, that its total holding in Syngenta now amounts to 3,189,989 shares (3.43% of the total share capital), split into 3,177,528 registered shares plus purchase rights on ADRs (ISIN US87160A1007, 1 ADR=0.2 share) corresponding to 12,461 shares.
