Enhanced Buffered Jump Securities Based on the Value of the Russell 2000<sup>®</sup> Index due February 29, 2024

**This document provides a summary of the terms of the securities offered by Morgan Stanley Finance LLC. Investors should review carefully the accompanying preliminary terms, product supplement, index supplement and prospectus prior to making an investment decision.**

#### SUMMARY TERMS

**Issuer:** Morgan Stanley Finance LLC (“MSFL”)

**Guarantor:** Morgan Stanley

**Stated principal amount:** \$1,000 per security

**Pricing date:** February 25, 2019

**Original issue date:** February 28, 2019 (3 business days after the pricing date)

**Maturity date:** February 29, 2024

**Underlying index:** Russell 2000<sup>®</sup> Index. For more information about the underlying index, see the accompanying preliminary terms.

If the final index value is **at or above** the downside threshold value:

\$1,000 + the *greater* of (i) \$1,000 + the index percent change and (ii) the upside payment

In no event will the payment at maturity exceed the maximum payment at maturity.

**Payment at maturity:**

If the final index value is **below** the downside threshold value:

$\$1,000 \times (\text{index performance factor} + \text{buffer amount})$

*In this scenario, the payment at maturity will be less than the stated principal amount, subject to the minimum payment at maturity of \$150 per security.*

**Upside payment:** At least \$250.00 per security (25% of the stated principal amount). The actual upside payment will be set on the pricing date.

**Index percent change:**  $(\text{final index value} - \text{initial index value}) / \text{initial index value}$

**Index performance factor:**  $\text{final index value} / \text{initial index value}$

**Initial index value:** The index closing value on the pricing date

**Final index value:** The index closing value on the valuation date

**Buffer amount:** 15%

<b>Downside threshold value:</b>	85% of the initial index value
<b>Maximum payment at maturity:</b>	\$1,500 per security
<b>Minimum payment at maturity:</b>	\$150 per security
<b>Valuation date:</b>	February 26, 2024, subject to postponement for non-index business days and certain market disruption events

## Overview

The Enhanced Buffered Jump Securities, which we refer to as the securities, are unsecured obligations of MSFL and are fully and unconditionally guaranteed by Morgan Stanley. The securities will pay no interest but will instead pay an amount in cash at maturity that may be greater than or less than the stated principal amount depending on the closing value of the underlying index **on the valuation date**. If the closing value of the underlying index on the valuation date is **at or above** 85% of the initial index value, which we refer to as the downside threshold value, you will receive, in addition to the principal amount, a minimum of the upside payment of at least \$250.00 per security (to be determined on the pricing date). If the underlying index appreciates by more than at least 25% (to be determined on the pricing date) over the term of the securities, you will receive for each security you hold at maturity the stated principal amount plus an amount based on the percentage increase of the underlying index, subject to the maximum payment at maturity. However, if the closing value of the underlying index on the valuation date is **below** 85% of the initial index value, you will be exposed to the decline in the level of the underlying index beyond the buffer amount of 15%, and you will lose some or a significant portion of your initial investment. These long-dated securities are for investors who seek an equity index-based return and who are willing to risk their principal and forgo current income and returns above the maximum payment at maturity in exchange for the potential to receive the minimum upside return if the

final index value is at or above the downside threshold value. **The payment at maturity may be significantly less than the stated principal amount, and you could lose up to 85% of your investment.** The securities are notes issued as part of MSFL's Series A Global Medium-Term Notes program. **All payments are subject to our credit risk. If we default on our obligations, you could lose some or all of your investment. These securities are not secured obligations and you will not have any security interest in, or otherwise have any access to, any underlying reference asset or assets.**

### **Hypothetical Payout on the Securities**

The payoff diagram below illustrates the payment at maturity on the securities, assuming a hypothetical upside payment of \$250.00 per security (25% of the stated principal amount). The actual upside payment will be set on the pricing date.

## Risk Considerations

The risks set forth below are discussed in more detail in the “Risk Factors” section in the accompanying preliminary terms. Please review those risk factors carefully prior to making an investment decision.

- The securities do not pay interest and provide for the minimum payment at maturity of only 15% of your principal.
- The appreciation potential of the securities is limited by the maximum payment at maturity.
- You will not benefit from the upside payment if the final index value is below the downside threshold value.
- The market price of the securities will be influenced by many unpredictable factors.

The securities are subject to our credit risk, and any actual or anticipated changes to our credit ratings or credit spreads may adversely affect the market value of the securities.

- As a finance subsidiary, MSFL has no independent operations and will have no independent assets.

The amount payable on the securities is not linked to the value of the underlying index at any time other than the valuation date.

The securities are linked to the Russell 2000<sup>®</sup> Index and are subject to risks associated with small-capitalization companies.

- The securities will not be listed on any securities exchange and secondary trading may be limited.
- Investing in the securities is not equivalent to investing in the underlying index.
- Adjustments to the underlying index could adversely affect the value of the securities.
- The rate we are willing to pay for securities of this type, maturity and issuance size is likely to be lower than the rate implied by our secondary market credit spreads and advantageous to us. Both the lower rate and the inclusion of costs associated with issuing, selling, structuring and hedging the securities in the original issue price reduce the economic terms of the securities, cause the estimated value of the securities to be less than the original issue price and will

adversely affect secondary market prices.

The estimated value of the securities is determined by reference to our pricing and valuation models, which may differ from those of other dealers and is not a maximum or minimum secondary market price.

- Hedging and trading activity by our affiliates could potentially adversely affect the value of the securities.

The calculation agent, which is a subsidiary of Morgan Stanley and an affiliate of MSFL, will make determinations with respect to the securities.
