Today, TELEFÓNICA, S.A., through its wholly- owned subsidiary TELEFÓNICA EMISIONES, S.A.U., under its Guaranteed Euro Medium Term Note Programme (EMTN Programme) filed with the Financial Services Authority (FSA) in London on July 3<sup>rd</sup>, 2009, has launched an issue of Notes guaranteed by TELEFÓNICA, S.A. in the Euro market amounting 650 million sterling pounds.

These thirteen (13) year Notes pay an annual coupon of 5.289% and have a reoffer price of 100%. Settlement and closing date is scheduled for execution on December 10<sup>th</sup>, 2009.
