Item 5.03. Amendments to Bylaws.

On April 7, 2010, the Board of Directors of Chesapeake Utilities Corporation (the Company) approved and adopted an amendment and restatement of the Company s Amended and Restated Bylaws (the Bylaws) effective as of the same date. The material amendments to the Bylaws provide for the following:

- (a) The Company s President no longer automatically serves as the Chief Executive Officer in the event the Chair of the Board has not been designated the Chief Executive Officer;
- (b) Certain powers and authority previously delegated to the Company s President pursuant to the Bylaws are now delegated to the Chief Executive Officer;
- (c) Written notice of a director resignation is given to the Chair of the Board and contemporaneously to the Secretary of the Company; and
- (d) The list of officers that the Board of Directors may appoint was expanded to specifically include a Vice Chair and a Chief Executive Officer and the duties of certain of the officers were clarified.
