Air Combat Maneuvering Instrumentation (ACMI) Systems  
Valued at approximately \$18 Million

Haifa, Israel, December 29, 2010 - Elbit Systems Ltd. (NASDAQ and TASE: ESLT) announced today that it was awarded an approximately \$18 million contract, for the supply of an EHUD® Air Combat Maneuvering Instrumentation (ACMI) system for an Asian air force. The contract is a follow-on order that calls for the supply of two additional complete systems (static and mobile) to be used for real-time, autonomous air-to-air and air-to-ground combat training and debriefing. The new systems will feature interoperability with an existing Elbit Systems' training system that the customer is already operating. The contract will be performed over the next two years.

Yoram Shmueli, Co-General Manager of Elbit Systems' Aerospace Division, said: "We are very proud to receive this follow-on order, which attests to the customer's satisfaction and solidifies the EHUD® ACMI systems' position as a world leading air combat training system.
