New Notes), which are fully and unconditionally guaranteed by F.N.B. Corporation, (the Company). The Company is no longer offering Outstanding Notes, and reserves the right to redeem Outstanding Notes which are not exchanged for corresponding New Notes. Holders of Outstanding Daily Notes will no longer be permitted to add to the outstanding principal balance of such Notes. Any outstanding Notes that are not exchanged will remain outstanding, and may be renewed or redeemed in accordance with their terms.
