## ADJUSTMENTS OF TARIFFS

This announcement is made pursuant to Rule 13.09(2) of the Rules Governing the Listing of Securities on the Stock Exchange of Hong Kong Limited.

Huaneng Power International, Inc. (the "Company") announced the adjustments of tariffs of some of its power plants. According to documents issued by the National Development and Reform Commission, the on-grid tariffs (including VAT) of some of Company's power plants are to be adjusted as follows:
